Overview

"Momentum" was the theme of the 30th USMB National Convention held July 26-27 in Santa Clara, Calif., and the motion repeatedly emphasized was moving forward with the mission of God. Among those who delivered that message were two keynote speakers who shared the same first name as well as a strong commitment to see people come to faith in Jesus Christ.

USMB Executive Director, Ed Boschman, gave the Saturday morning address. "We are on mission. We have the right message for this time. We're Bible-believers. We're Jesus centered. We're Spirit led. We call people to repentance. We are agents of reconciliation and peace. We are a covenant community. We are what our neighbors need," said Boschman.

Ed Stetzer, who was also the speaker for the National Pastors Conference, focused on church multiplication in his Friday evening keynote address. "There is a motion to the mission," said Stetzer, referring to John 20:21. "Don't let your church be a cul-de-sac on the Great Commission Highway." Stetzer went on to challenge U.S. Mennonite Brethren to plant churches in the subcultures—the "divots"—of today's world.

And that is just what USMB church planters are doing, said Mission USA director Don Morris in his report Saturday morning. "We are finding those divots in which to plant churches," said Morris.

A USMB priority that gained traction over the two-day convention was unity in spite of disagreement about how U.S. Mennonite Brethren can best express our understanding of peacemaking. Delegates discussed and voted on a revision to Article 13 of the USMB Confession of Faith. Board of Faith and Life Chair Larry Nikkel gave a review of the lengthy process has taken over the past four years. This included 20 steps taken, from an initial survey at the 2010 convention, to processing revisions with and receiving feedback from leaders and pastors from all five districts as well as other groups. Much floor discussion time was given at this convention as well as a workshop to also aid in the process. Speakers affirmed the time and energy that BFL had invested in the process and recognized that the revision had been crafted carefully with thought given to each word and phrase with the goal of writing a statement that all USMB pastors and teachers will support. The revision was approved, making this the first time an article has been changed since the Confession of Faith became a national rather than binational North American statement.

Saturday afternoon, Ed Boschman, who retired July 31, was recognized for 40 years of service as a pastor and conference leader. Referring to Boschman as the "evangelistic conscience" of U.S. Mennonite Brethren, Gary Wall, the Pacific District Conference minister, said of Boschman,

"You remind us often that unless Jesus saves and transforms a lost soul, we're missing the mark of what it means to be a faithful people." In addition to Wall, Steve Schroeder, Leadership Board Chair; Larry Nikkel, Board of Faith and Life chair; and Terry Hunt, North Carolina District minister, pastor and former Leadership Board member, reflected on Boschman's ministry. All four affirmed Boschman's bold and godly leadership gifts. Hunt washed Boschman's feet as a sign of how much he was appreciated by USMB pastors, leaders and constituency. Boschman was also honored with a standing ovation.

National Pastors Conference

Pastors and spouses from USMB congregations across the U.S. gathered July 24-25 prior to the national convention for a time to reconnect and refuel. Ed Stetzer was the keynote speaker for two sessions and fielded questions from attendees during an additional question-and-answer session. Stetzer is president of LifeWay Research, an author, pastor and church planter. He focused on the "one mission" part of the USMB mission statement. He cited research that indicates that the majority of people in the majority of churches in North America are unengaged in meaningful mission. He encouraged attendees from I Peter 4, saying that all have gifts, which God intends all to use and for which he empowers, in order to bring God glory. He challenged pastors to remove obstacles to congregants owning the mission, which may mean rethinking building structures or ministry roles. He also asked the question, how will the church respond to major cultural shifts? His answer, from 2 Corinthians 5 was to talk about receiving anew view, being sent on a mission of reconciliation and representing Jesus and his kingdom. He repeatedly reminded attendees that personal transformation is the motivation for mission. "The world doesn't need more nice people' it needs people who have been changed."

Worship for both the National Pastors Conference and the National Convention was led by John Szablowski and his worship team from The Bridge Bible Church in Bakersfield, Calif.

I. INTRODUCTION TO THE CONVENTION RECORD

Presiding Officers were: Steve Schroeder, Chair Marv Schellenberg, Vice Chair Ed Boschman, Executive Director

The theme of Conection 2014 was "Momentum." The scripture which founds and informs that theme is from Hebrews 12:1-2, "We'd better get with it...start running and never quit...keep your eyes on Jesus" (The Message translation). When the arrival of the Holy Spirit occurred at Pentecost, the church was ignited. Because we are in the lineage of the Christian believers, we too have been ignited by the presence and power of the Holy Spirit. Because of the Spirit's faithful work in and through us, we have the privilege of momentum.

II. Session 1, Friday afternoon, July 25

Chair Steve Schroeder opened the session with song and prayer. Roll call was taken by having all delegates stand by district. Delegates were present from all five districts. The convention was then called to order.

A. Appointments: The following appointments were made:

Parliamentarian: Dennis Fast (PDC)

Minute Review Committee: Amy Stone (PDC), Linda Oelze (SDC), Luke Haidle (CDC)

Willy Reimer, Executive Director of the Canadian Conference of Mennonite Brethren Churches, gave a brief report and welcome from the CCMBC.

Schroeder invited the delegates to have a time of prayer around the tables.

Schroeder introduced and welcomed Lynn Quiring and Lawrence Sawatsky, delegates from First Mennonite Church in Clinton, OK. This church is in the process of joining the U.S. Conference and the Southern District Mennonite Brethren Conference. He also introduced representatives from the following partner agencies:

- David Wiebe ICOMB (International Community of Mennonite Brethren)
- Ron Byler MCC (Mennonite Central Committee)
- Cesar Garcia MWC (Mennonite World Conference)
- Gord Fleming and Ron Leonard C2C Network, Canadian Conference of MB Churches
- Rick Stiffney MHS (Mennonite Health Services)
- Jeff Koller MDS (Mennonite Disaster Services)

B. Recommendations

Schroeder then briefly previewed the following recommendations that were presented to the delegation from the Leadership Board for action later in the convention:

- 1. The Bylaw change of the USMB bylaws, Article 1, Section 4 regarding the conference fiscal year.
- 2. The election and/or affirmation of the presented nominations.

- 3. The approval of the revised Article 13 of the Confession of Faith. Steve notified the delegates that according to the bylaws, no new recommendations can made at this convention nor can anyone comment more than three times on each recommendation.
- 4. The approval of the revised Historical Commission MOU.
- 5. The approval of the revised MB Mission bylaws and ratification of the Canadian bylaws.

C. Reports

1. Tabor College Report - Jules Glanzer, President

President Glanzer showed a video, gave a brief update and shared statistics and stories of the positive affect Tabor College is having on the students. Glanzer announced that Tabor College is celebrating 106 years of education. Delegates were invited to read the full report in the convention booklet.

Tabor College Wichita - *Rick Bartlett, Director of Theological Education*Bartlett shared about the new Masters of Arts in Entrepreneurial Ministerial Leadership degree offered at Tabor College Wichita.

Steve Schroeder invited the delegates to share in a time of prayer at their tables for Jules Glanzer/Tabor College and Rick Bartlett/Tabor College Wichita.

2. Fresno Pacific University - Pete Menjares, President

President Menjares shared that it was two years ago at the 2012 convention when he began his role as president of Fresno Pacific University. FPU is the second largest private university in the San Joaquin Valley. Menjares shared that both FPU and Tabor College are ministering to "the remnant," as Christian higher education makes up only 2% of all the higher education in the US today.

Fresno Pacific Biblical Seminary - Terry Brensinger, Dean

Terry Brensinger shared that he has almost completed one year of service as the dean of FPBS. Brensinger assured the group that the seminary is committed to educating pastors and announced a new staff member, Brian Ross (not present), who has a heart for church planting and training MB pastors to lead those churches.

Schroeder invited the delegation to share in a time of prayer at their tables for Pete Menjares, Terry Brensinger and both institutions.

Schroeder offered appreciation to some of the sponsors of the convention: Mennonite Central Committee, Kindred Productions and MB Foundation. He then invited Jon Wiebe, President of MB Foundation, to share a brief explanation of a few services offered by MB Foundation to the USMB pastors and congregants.

Amy Stone, from College Community Church in Clovis, Calif., prayed for the evening meal.

III. Session 2, Friday evening, July 25

In the evening session, after a time of worship, Executive Director Ed Boschman invited the delegation to "come to the table" in communion. The delegates spent time in prayer and

shared the elements at their respective tables. The guest speaker for the evening session was Ed Stetzer.

IV. Session 3, Saturday morning, July 26

Keynote Address - Ed Boschman, Executive Director

After an opening song, Ed Boschman opened the Saturday morning session with his keynote address titled, "The Greatest of These." He began by reading from Isaiah 41:10 and led the delegation through a journey from the Gospel of John. Boschman called the group to pursue unity with passion "so that the world may know." Boschman invited the group to close their eyes and ask Jesus to show them any disunity among us, ask for forgiveness and make amends. The message of John consistently reminds us that Jesus called us to love one another. Boschman then read through Hebrews 12:1-2, the theme version for the convention, from *The Message* translation. Boschman closed with the reading of Psalm 115:1 which emphasizes that because of His love and faithfulness all the glory belongs to Him. Boschman closed in prayer.

3. Mission USA Report - Don Morris, Director of Mission USA

Don Morris shared what God is doing all across America in our USMB family. Morris invited the district ministers to stand and for the delegation to show appreciation for all they do within their districts and our USMB family. Morris shared that the goal of Mission USA is to plant churches and resource our existing churches. Morris confirmed that he and the USMB staff are retaining the vision to plant six churches each year and strive to be faithful to the mission they believe God has given.

Morris invited the following church planters to share what is happening in their new church plants:

Christ Church Sellwood Church, Portland, OR- Jared Pulliam (via video)

The GreenHouse, Saratoga Springs, UT – Jason and Nicole Quiring

Friends of Jesus, Las Vegas, NV – Aris and Ana Tolentino (first MB church in Nevada)

Grace Point, McAllen, TX – Aaron and Alejandra Hernandez

Axiom, Peoria, AZ - Gavin and Kendall Linderman

Disciples Church, Spokane, WA – Aleks and Vera Borisov

Morris emphasized that all these church plants are possible because of partnerships with their districts, other churches and personal donors.

Prayer was given for the church planters and an offering of \$3000 was received specifically for church planting.

V. Session 4, Saturday morning, July 26

4. Christian Leader/Social Media Report - Connie Faber, Myra Holmes

Connie Faber, Editor of the *Christian Leader*, and Myra Holmes, the associate editor of CL and the social media coordinator, gave brief reports from both the *Christian Leader* and the progress of our technological advances due to social media. Faber reported that US Mennonite Brethren have been reading the *Christian Leader* for 77 years.

Myra Holmes acknowledged and thanked the social media volunteer team who helped promote the events on this convention via our hash tag #USMB2014. That team consisted of Justin Hiebert, JL Martin, Tim Neufeld and David Buller. Myra introduced *USMB Pulse*, a new resource on the USMB website offering news and stories of transformation from the USMB family.

Connie Faber presented Matt Ford, Fresno Calif., the award he earned for writing an article for the *Christian Leader*. Ford's article received 5th place in the Higher Goals Cause of the Year from the Evangelical Press Association.

5. Kindred Productions Report – Amy Sterk, US Representative

Sterk explained how Kindred Productions serves as the publishing arm of the MB churches in both the United States and Canada. KP worked with the USMB to develop a bundle of books offered at a reduced price to our church planters and new pastors.

Vice Chair Marv Schellenberg invited the delegates to share in a time of prayer at their tables for the *Christian Leader* and Kindred Productions staff and ministries.

6. Board of Faith and Life - Larry Nikkel, Chair

Larry Nikkel, chair of the USMB Board of Faith and Life, called the other BFL board members to join him on the stage. The board members present were Tim Sullivan, Gary Wall, Terry Hunt, Rick Eshbaugh and Tim Geddert. Nikkel explained that Ed Boschman is also a board member but his role can be described as having "a voice but not a vote."

Nikkel gave some background to the proposed change to the Confession of Faith Article 13 and explained that this has been a 20-point process over the past four years. The process began at the USMB convention in 2010 where a survey was conducted asking for feedback from the delegates regarding how we are living out the Confession of Faith. Those survey results indicated that only 22.9% of the delegates reported that our constituency "walked the talk" as it relates to Article 13 and 57% of delegates said there should be a review and possibly a revision to this article.

Larry identified three alternatives considered by the BFL in response to the survey: 1) leave everything as it is, even knowing that many pastors are given to either ignore or speak against Article 13; or 2) remind pastors and teachers that they are expected to preach and teach all of Article 13 as they covenanted to do; or 3) initiate a review and

possible revisions which could lead to a deeper understanding and commitment to the essence of Articles 12 and 13. It was the decision of the BFL to accept this third option and call for broad participation at a study conference to review Articles 12 and 13.

In January 2013, a study conference was held in Phoenix, Ariz. Based on 213 pages of evaluations, survey results and comments from the participants, the BFL determined that no change should be made to Article 12. However, a revision of Article 13 was drafted. In March 2013, this drafted revision was sent as an "open letter" to the study conference participants and pastors and was also posted on the USMB website. The *Christian Leader* established an electronic forum and invited others to participate in this process.

The BFL again reviewed feedback and comments and wrote a second draft and distributed it to the constituency in another open letter in June 2013. The BFL then shared this process and sought council from ICOMB, MCC, the Canadian Mennonite Brethren Board of Faith and Life and other Mennonite individuals for their review and comments. The BFL conducted face-to-face meetings for further clarification, input and counsel with each district Boards of Faith and Life, the seminary, college and university Bible faculties as well as churches and other affiliated groups.

After these results and feedback were processed, a third draft was distributed in September 2013. This draft was considered a preliminary recommendation. In October 2013, an electronic survey was sent to all pastors asking for their response to this preliminary recommendation. The BFL reviewed these survey results and formulated the final revision in March 2014. This recommended revision was published in April 2014. The BFL also met with the leaders of the LAMB conference to brief them and receive their input in May 2014.

The review and revision of Article 13 has been the primary agenda item for the BFL in their last eight meetings. Early in this process, the BFL made a commitment to integrity with what the Scriptures teach; with what we publicly claim; and with the International Community of Mennonite Brethren and other peace churches.

The goals and objectives of the BFL have been to 1) refocus Article 13 around a positive call to "love, peacemaking and reconciliation" rather than focusing around the negative term "nonresistance;" 2) reaffirm our basic commitment to being a peace church; 3) move the focus from the issue of military to a broader understanding of peacemaking (in families, churches and communities); 4) speak with integrity on the issue of military participation, taking into account that all do not agree, nor make the same choices; 5) emphasize the Lordship of Jesus as the basis for all Christian decision-making; 6) adopt a confessional article that can be an effective platform on which we can build, which we can promote, and which we can consider normative for Bible teachers, pastors and other leaders.

The core objective has been to be fully unified in our commitment to Jesus' way of peaceful living and peacemaking in all we say and do.

Larry Nikkel invited Tim Geddert to discuss the ways in which the recommended Article differs from the current Article, specifically focusing on the issue of military service.

The floor was opened to questions from delegates:

<u>Elmer Martens</u> (North Fresno MB Church): Martens asked how our actions will impact our MB churches in other countries. Martens requested that David Wiebe (ICOMB) comment on his opinion of how this is viewed in places abroad.

<u>David Wiebe</u> (ICOMB): Wiebe expressed appreciation for being included in this process, as it offers a strong practical expression of participation in our global community. Wiebe was encouraged that USMB was concerned about the global opinion. Wiebe shared that the global gathering in Peru felt good about the new title and some of the improvements on the (more clear) wording. Wiebe shared some comments from the global leaders who expressed that they are facing difficulties due to many different ethnic groups, children taught self-defense at an early age, and those extremely involved in national patriotism.

<u>Brad Burkholder</u> (Hesston MB): Burkholder shared that he sent the revised draft to his congregation and received comments from those who served in military noting that the reason they serve is to promote peace and reconciliation. Burkholder shared his appreciation for opening this discussion about peace.

Brent Warkentin (First MB): Warkentin expressed his support for this good end product, but also asked, "How do you respond to people who feel that this is watering down our stance?"

<u>Tim Geddert</u> (BFL): Geddert responded that it isn't so much watering down versus stating strongly; rather it's finding the common ground that can we confess together.

<u>LouAnn Voth</u> (Koerner Heights): Voth shared her concern that this is not encouraging other churches/leaders to support the non-military stance.

<u>Sam Wall</u> (Madera Avenue MB): Wall shared that he served as a conscientious objector in the 1960's. Wall is in favor of the proposed draft revision.

Frank Lenihan (Lustre MB): Lenihan shared his opinion that the main issue is the confusion that ensues when churches allow pastors who don't support the peace position to take leadership roles in our MB churches. He is pleased that the process has brought us to this point and has allowed everyone to have an opportunity to speak into this process. Lenihan is in favor of the new language; specifically because of its potential to increase the integrity of our pastors as it relates to the full support of Article 13.

<u>Harold Voshage</u> (Lincoln Glen, San Jose): Voshage shared that Article 13 is the basic tenant of us as Mennonite Brethren. Voshage feels strongly that we need to maintain our position as a peace church stating, "this is who we are."

Larry Nikkel closed the discussion and encouraged all who desire to continue this discussion to attend the BFL-Confession of Faith, Article 13 workshop.

7. MB Foundation Report - Jon Wiebe, President

Jon Wiebe asked delegates to review the reports on the table and in the convention booklet. Wiebe shared that MBF contributes a first-fruits gift to USMB annually. They also provide an online monthly devotional titled, "Giving Meaning to Money." Wiebe introduced their new promotion designed to inform and encourage participation in the Donor Advised Fund. Wiebe invited the MB Foundation staff who were present- Christine Wall, Jeffrey Jorgenson and Bruce Jost to share stories of generosity from their perspective.

8. ICOMB Report - David Wiebe, Executive Director

David Wiebe brought greetings from the global family of MB churches. He encouraged the constituency to take courage from and pray for these conferences around the world that are growing in spite of poverty and oppression. Wiebe shared that many churches are on mission in very politically unstable areas. All delegates were invited to sign up to receive the ICOMB monthly prayer updates.

Steve Schroeder introduced Dave Buller, pastor of Cornerstone Community Church in Topeka, Kan. and chair of the Southern District Conference. The SDC sponsored the noon meal as a show of support for and partnership with the US Conference.

Schroeder invited Tim Bergdahl and Ron Voth, who both have cancer, to come forward and share brief testimonies and gratitude to their MB family.

Jodi Thomas (Bible Fellowship Church, Sioux Falls, SD and US Leadership Board member) prayed for the lunch meal.

VI. Session 5, Saturday afternoon, July 26

9. MB Mission Report - Randy Friesen, Executive Director

Friesen shared a video from a trip to Laos and Thailand with some of the US and Canadian MB pastors and leaders. He gave a brief report of the many ways MB Mission is bringing the Good News to the least reached around the world. He then introduced Ricky Sanchez who shared a life-transformation story about how Christ, through MB Mission, has changed the life of a young girl named Bing-Bing.

Friesen invited Tony and Roxanne Petersen, new missionaries to Germany, and Jason Clark, who with his family are new missionaries to Mexico, to come forward for prayer.

10. National Youth Committee Report – Matt Ford, Russ Claassen and Joanna Chapa (committee members)

Ford, Claassen and Chapa gave a report about the progress and planning for the National Youth Convention titled, Named2015. The event will be held in Denver, Colorado in April 2015. The committee announced that the band will be *For All Seasons* and introduced the speaker, John Richardson, who shared his excitement to minister to the students who will attend Named2015.

11. Historical Commission Report – Jon Isaak, Executive Secretary

Isaak shared that the Historical Commission serves and is accountable to both the US and Canadian MB conferences. Isaak informed the delegates of the four archival centers—two in the United States and two in Canada. The HC produces *Profiles*, a publication of stories of Mennonite faith.

12. Mennonite World Conference (MWC) – *César Garcia, General Secretary* MWC is called to be a communion of Anabaptist-related churches linked to one another in a worldwide community of faith for fellowship, worship, service and witness. Garcia gave a report about the growth of the Mennonite churches around the world.

Steve Schroeder invited the delegates to share in a time of prayer at their tables for MB Mission, the National Youth Convention, Historical Commission and Mennonite World Conference.

D. Recommendations

The delegation voted on the following recommendations:

a. **Bylaw change.** The USMB Leadership Board recommends the approval of the Bylaw change of Article 1, Section 4, first sentence to read: Fiscal Year. *The fiscal year of the Conference shall begin on January 1 in each year*. This change is effective retroactive to January 1, 2014.

- b. **Elections.** The USMB Leadership Board recommends the election and/or affirmation of the presented nominations. Aaron Box, Eugene, Ore., was added to the list of Leadership Board nominees. *MSC*
- c. **Revision of Article 13.** The USMB Leadership Board joins the U.S. Board of Faith and Life in recommending the approval of the revised Article 13 of the Confession of Faith.

Motion made and seconded.

Discussion:

<u>Trent Voth</u> (College Community Church, Clovis, Calif.): Voth shared that in the spirit of remembrance, we must remember who we are and that after we have come so far we not give up our cry for peace.

<u>Willy Reimer</u>, (Executive Director of Canadian Conference): The CCMBC Board of Faith and Life affirmed the process at the Study Conference in Phoenix in 2013. They want to continue to support, encourage and affirm the USMB as they go through this process.

Ballots were distributed to the delegates.

The revision of Article 13 was passed by a vote of 103 YES to 10 NO.

Additional comments:

Gary Wall (PDC District Minister) expressed appreciation for Ed Boschman, Tim Geddert and Larry Nikkel for taking the weight of most of the work during this long process.

Lynn Jost (Ebenfeld MB Church, Hillsboro, Kan.): issued this challenge and recommendation to the BFL: "We, the USMB Conference mandate the Board of Faith to foster communication within our congregations to encourage the study of, commitment to and growth in Biblical love, peacemaking and reconciliation guided by our MB Confession of Faith Article 13 and to report the response of congregations to this initiative at the 2016 convention."

MSC

<u>Amy Stone</u> (Clovis Community Church, Clovis, Calif.): Stone asked where the obligation falls to collecting the data from the mandate given.

Steve Schroeder clarified that BFL would be responsible to initiate the presentation to the congregations and report at the 2016 convention.

- d. **Historical Commission MOU**. The USMB Leadership Board recommends the approval of the revised Historical Commission Memo of Understanding as presented *MSC*
- e. **MB Mission Bylaws.** The USMB Leadership Board recommends the approval of the revised MB Mission Bylaws as presented and ratification of the Canadian Bylaws. *MSC*

E. Transition of Executive Director

Schroeder recognized the contributions from USMB Executive Director, Ed Boschman. He invited Gary Wall, Larry Nikkel and Terry Hunt to express their appreciation for the leadership of Boschman over these past seven years. The speakers each affirmed Boschman for his ongoing passion to see lives transformed by Jesus Christ and his gifted ability to be a bold leader, mentor and friend. Terry Hunt then washed Ed Boschman's feet. Ed received a standing ovation.

Ed Boschman gave Don Morris a gift along with words of encouragement for this next season as Morris takes the role as interim executive director. Morris also expressed his deep appreciation for the leadership and friendship of Ed Boschman.

The participants stood in prayer for Don and Janna Morris and Ed and Carol Boschman.

Amy Stone of the **Minute Review Committee** announced that the minutes were read and approved as taken.

Motion made and seconded.

The convention was adjourned with prayer.

Please pray as well for our USMB Leadership Board as they have significant responsibility to carry the ministry of our National Conference forward. The hopes and prayers that the best days for USMB are still before us are both theirs and ours.

Life Insurance

The Church Workers Group Life Insurance Plan continues to be a good benefit for our pastors, district and national staff by providing modest term life insurance coverage.

Retirement Plan

The Church Workers/Pastors Retirement Plan (MRT) is administered by Great-West Retirement Services. Churches are encouraged to enroll their church staff and contribute a minimum of 6% of salary with the staff member voluntarily participating at a minimum of 3%. Having retirement income designated as housing allowance is one possible significant benefit for pastors remaining in the denominational retirement plan.

Annual IRS Reporting

Annual reports are submitted to the Internal Revenue Service to maintain the Group Exemption status for the USMB Conference and member churches as 501(c)3 tax exempt organizations. USMB Churches obtain and maintain their tax exempt status from being a part of USMB.

National Pastors Orientation

NPO is an event held every two years to provide fellowship, connection, resources and information for pastors and their spouses who are either new to the denomination or new to ministry.

A special conference every two years for all USMB pastors and their families held prior to the national convention. This event is intended to provide inspiration, encouragement, instruction and fellowship.

National Convention

Biennial delegate convention brings together the national MB family in a time of celebration, inspiration and fellowship. Board and ministry reporting and denominational business are also processed.

National Youth Conference

Quadrennial gathering for high school youth for inspiration, discipleship training and experience. Next event is April 2015 in Denver!

Church and individual donations are receipted for USMB national ministries including church plants, as well as for Fresno Pacific Biblical Seminary, MCC and MDS. These funds are then distributed to the various ministries, agencies or church plants.

Mission USA, the church planting and renewal arm of USMB, exists to do everything possible within its capacity for the transformation of individuals, families and communities in the name of Jesus. Or, in other words, "to see more... come to know Him!" Specifically, Mission USA seeks to be integrally involved in helping plant more MB churches across America, which in turn reproduce and continue to plant even more churches. New church plants are highly effective in reaching those who don't know Jesus yet with the Good News. In addition, and in collaboration with our districts, Mission USA has developed a church leadership enhancement initiative called LEAD (Leadership Education and Development).

Our vision: To help plant 6 new MB churches each year.

If we're to be highly aggressive in starting many more reproducing churches, then we must have qualified church planters for the work involved. Along with district leadership, we are consistently searching for qualified individuals who have the necessary gifts required for successful planting—it's a process. In addition, potential church planters are always assessed by an independent church planter assessment center. We also need considerable resources for planting. The USMB staff is involved in raising a large portion of the money needed for Mission USA's investment in church planting and renewal, adding to the funds received from our member churches. Your individual and collective participation in giving to Mission USA is greatly appreciated!

The national LEAD Initiative includes LEAD ONE—intensive, one-day, regional, leadership training events. The feedback following these regional events has been quite positive and many more events will follow in various regions around the country. Watch for a LEAD ONE coming near you this coming year.

Other components of the LEAD program are LEAD Labs (1-2 hour on-site training segments for leadership teams), CHAT Church Health Surveys/Consultations, and LEAD Coaching (a coaching network of trained MB coaches for pastors). Ed Boschman, retiring USMB executive director, will serve as the head coach beginning August 1st. Ed will provide valuable leadership as we provide our pastors/leaders with life-on-life coaching.

Our goal is that the LEAD initiative will make a tangible difference for our existing churches, building and maturing over time, consistently providing more tools for the leadership tool chests of our pastors and church leaders. Watch for future developments!

Collectively, MBs have consistently expressed that Mission USA must be an integral component of our overall strategy for facilitating church vitality, growth, reproduction, unity and commitment. We strive to reach those goals. A little information on our current projects is listed below. Again, partnership with our MB churches and districts makes it possible to achieve much more than any one entity could separately.

Church Plants and Projects:



Axiom Church, Peoria, Arizona – Axiom Church held their public launch July 2013. Gavin & Kendall Linderman are the church plant couple. This young church has baptized several over the past year and they have a passion for reaching "the unlikelies." Gavin previously served as an intern at Copper Hills Church (Glendale, AZ) under Pastor Brad Klassen. Copper Hills is supporting this plant as the mother church. The church has grown considerably this past year. [In partnership with the PDC]



Grace Point @ **La Grulla**, **McAllen**, **Texas** – Grace Point @ La Grulla (previously La Grulla MB Church) is a progressive church in the LAMB district, reaching many people in the southern tip of Texas. Pastor Aaron Hernandez and his wife, Alejandra, along with key core team members, planted a multisite campus in McAllen, the largest city in the area, in 2012. The new Grace Point @ McAllen church recently moved into a renovated church building in the northern part of the city, providing much-needed space for growth. Good things are happening at this new campus.



Christ Church Sellwood, Portland, Oregon – Jared & Julia Pulliam are the church plant couple of Christ Church Sellwood. This new MB church launched in early 2013 and meets at the Sellwood Community Center. Sellwood is a developed city/neighborhood in Portland with beautiful older homes, coffee shops and a hometown atmosphere. The core team is fully committed and fruit is beginning to come. [In partnership with the PDC and Trinity Church of Portland]



Stony Brook Church, Omaha, Nebraska – Stony Brook Church started in October 2010 and has grown steadily since then. Chad & Elaine Stoner are the church plant couple and were joined by Stephen & Mary K Humber in 2011. The church has grown largely through life-transformation. Baptisms are common and discipleship is a high value. The church is blessed with dozens of children. This adds up to a space problem—solutions are in development. [In partnership with the CDC]



Sanctuary Fremont, Fremont, Nebraska – Sanctuary Fremont is a brand new church plant project in this city of 26,000 located northwest of Omaha. Wes & Michele Wilmer are the church plant couple. Wes will serve as "resident church planter" with Stony Brook Church for several months while spending time building the plant's core team and raising funds. Anticipated launch is late 2014 or early 2015. [In partnership with Stony Brook Church and the CDC]



Disciples Church, Spokane, Washington – Disciples Church was launched in 2013 as a daughter church of Pilgrim Slavic MB Church (Spokane) and the first ever 2nd generation MB Slavic church plant in the U.S. Aleks & Vera Borisov are the church plant couple. The core team is highly committed and motivated to reach the community. Currently meeting in a small, isolated Baptist church building in the southern part of the city, a move to a more city-central location is being sought. [In partnership with Pilgrim Slavic MB Church and the PDC]



Mountain View Community Church Sunnyside, Fresno, California – Mountain View Community Church Sunnyside began services under the leadership of several interns in September 2012. John & Sarah Richardson became the full-time planting couple in the fall of 2013. Meeting in a school gym in southeast Fresno, the church has grown steadily in this diverse cultural setting. This is a daughter church of Mountain View Community Church and Mission USA is partnering.



The GreenHouse Church, Saratoga Springs, Utah – The GreenHouse Church is now the fifth MB church in Utah. Located south of Salt Lake City in Utah County, this new MB church is in a 90+% Mormon area. Jason & Nicole Quiring are the church plant couple having moved to Saratoga Springs in the summer of 2013. Many neighborhood connections have already occurred. [In partnership with the PDC, Henderson MB Church (Neb.), Fairview MB Church (Okla.)]



Iglesia Biblica de la Gracia, Mission, Texas – Iglesia Biblica de la Gracia launched January 2013 under the leadership of church plant couple Williams & Elurden Velez. Located in the northern part of this city in the southern tip of Texas, the church ministers to people experiencing considerable challenges, including poverty and broken families. The church meets in a small, enclosed building. A new location is needed, but necessary re-location funds are lacking. [In partnership with Mission MB Church (Mission, Tex.), Grace Bible Church (Gettysburg, SD) and the LAMB District]



Friends of Jesus Church, Las Vegas, Nevada – Friends of Jesus Church held their public launch in their new (rented) facility on January 26, 2014. This loving congregation, under the leadership of planting couple Andy & Leah Basilio, along with associate planting couple Aris & Ana Torentino, has a passion for meeting the needs of people in this city. The core team consists of Filipino and American heritage. Approximately 80,000 Filipinos live in Las Vegas, thus ministry opportunities are endless. [In partnership with the PDC]

Note: Additional projects/church plants are in development. Please pray that we understand clearly the vision and plans of the Lord of the Harvest, not our own, as we move forward "to see more ... come to know Him!"

It is the pleasure of the Board of Faith and Life (BFL) to serve our churches and members in matters of faith and life. We have continued various of the initiatives of the past as reported below. However the most significant and time consuming task we have undertaken is the result of the 2010 convention at which the need for the review of Article 13 became apparent.

The Study Conference

Much of our time in the 2010-2012 biennium was dedicated to planning the January 2013 Study Conference held in Phoenix. The focus of the Study Conference was Article 12 (The Society and the State) and Article 13 (Love, Peace and Nonresistance). The evaluations of the conference were very positive and resulted in more than 200 pages of presentations, evaluations and comments. Much of this material was made available to interested persons following the conference. The only exception pertained to one survey in which participants were encouraged to disclose the most frequent causes of congregational conflict.

Based on the feedback received from the participants, the BFL chose to make no changes to Article 12 but rather to exhort our pastors, leaders and teachers to call our members to a clear understanding that our priorities as Kingdom citizens must always take precedence over our priorities as national citizens. We agreed to design and carry out a process that could result in a revision of Article 13. We did so after much discussion and prayer, and with some fear and trembling; especially in view of a few voices cautioning us against embarking on such a contentious journey. We committed to a process of integrity and openness.

To summarize, we sent an open letter to all pastors and study conference participants along with a first draft of a potential revision, conducted meetings with our college, university and seminary Bible faculties, met with interested groups, visited each of our districts first to engage them and to test our draft(s), and later conducted workshops at district conventions, and invited the International Community of Mennonite Brethren (ICOMB), the Canada BFL, the Mennonite Central Committee and the Mennonite World Conference for their review and feedback. The Christian Leader kept the constituency informed through articles and updates and the USMB website and Social Media department also provided forums for dialogue.

Our third draft is the one being presented for your consideration. We believe that your active participation has resulted in the strongest of the three drafts. We also believe that it has integrity with the biblical call to peacemaking (although we do not all agree on the specific forms that may take), that it has integrity with what we publicly claim (recognizing that some of us want specific behavioral implications of a call to peacemaking to be stated and others do not), and that it has integrity with the ICOMB and other peace churches confessions (recognizing both the value of our historical roots and the need for ongoing discernment.)

Believing the above to be the result of a Spirit led process through which we carefully considered each suggestion for changes to the drafts, we now ask for your support of the statement. Furthermore, we exhort our pastors, teachers and leaders to be faithful in living out this essential component of our faith commitment – the Gospel of Peace.

Pamphlet Series

We continue to print the Faith and Life Pamphlet Series as time and finances allow. To date we have printed the following pamphlets, all of which are available in your churches or through the U.S. Conference Office.

Who are the Mennonite Brethren?, What We Believe, Dealing With Money, Human Sexuality, Sex Before Marriage, Faith and Social Media, Baptism and Church Membership, Christians and Media

Covenants

In 2012 we approved a Pastors Covenant in which pastors pledge how they intend to attend to personal and professional issues related to their ministry and later a congregational covenant in which congregations pledge how they will work with the pastor to affect a meaningful ministry. These documents are available from the District Ministers.

Canada BFL Study Conference on Human Sexuality

Several of our BFL members attended a study conference sponsored by the Canada BFL that focused on issues of human sexuality.

Legal Issues Related to Same Sex Marriage

Several churches have raised the issue of what degrees of freedom local churches have on issue dealing with requests which may come from members or the community related to same sex marriages. With the help of legal counsel we have distributed a statement from the BFL to the Districts that can be used to deal with this issue.

National Pastors Conference

We are in the planning stages for the next scheduled National Pastors Conference to be held in San Diego March 2015.

Continuing Education for Pastors

On line courses are now being offered by the Fresno Pacific Biblical Seminary and by Tabor College. While the various Districts have their own guidelines regarding these courses, all pastors coming into Mennonite Brethren churches are encouraged to complete at least one of the courses within three years. These courses are also available to other interested persons.


MOUs

As reported previously, we are operating with two Memorandums of Understanding. One is the replacement MOU between the Canada and the U.S. Boards of Faith and Life. The new MOU is primarily between the executive bodies of both conferences with the primary communication mechanism being the annual meeting of leaders from both conferences. This CAN/AM meeting is typically held in Denver the first week of December.

The other MOU is between our BFL and the Fresno Pacific University Biblical Seminary. We have attempted to have a face to face meeting with representatives of the Seminary and the BFL on an annual basis. The most recent meeting was held in September 2012.

We are blessed with competent and dedicated members of the board. We wish to express our appreciation to Michael who concludes his term of service with the conclusion of this meeting. Mennonite Brethren Historical Commission Report 2014

The four MB archival centers—Fresno, Hillsboro, Abbotsford, and Winnipeg—since the last convention report in 2012, continue to be busy offering research and archiving services to MB Churches and individuals in North America and beyond. Our two "deliverables" are archival resourcing and interpretive resourcing.

- **Archival resourcing** includes preserving and making accessible church records (photos, minutes, reports, statistics, etc.). See **www.mbhistory.org** and follow links to each center's website.
- *Interpretative resourcing* includes offering analysis on questions of theology and history as requested by individuals, congregations, and conference ministries. See sampling of projects below.

The ongoing task of producing resources for MB Churches has resulted in the following initiatives:

- **Profiles of Mennonite Faith**, distributed to all MB Churches. These pamphlets feature stories of remarkable Christian faith, of individuals who overcame great odds to share their faith in Jesus.
- Archival Internships, awarded to two students: Amanda Bartel (2103) and Yoshio Fujii (2014). The internship involves exploration and project work at each of the four archival centers.
- Research Grant, awarded to Kristine Kampen and Dorothy Peters for their project: From Generation to Generation: The History and Transmission of the Spiritual Formation of Two Granddaughters.
- It Happened in Moscow by Maureen Klassen, published in 2013—a riveting story of a family, a secret that spans revolution and war, and a stunning discovery. See www.kindredproductions.com.
- **Newsletters/Magazines** published: California Mennonite Historical Society Bulletin (Fresno), Roots and Branches (Abbotsford), CMBS Newsletter (Hillsboro), and Mennonite Historian (Winnipeg).

When the National Planning Team gathered after San Antonio 2011 to begin planning the next youth conference one thing stood out to us: Connecting. We had built a solid foundation of connecting with the cities (i.e. Anaheim 2007 and San Antonio) but we wanted to deepen and expand those connections throughout the conference. We wanted to have Youth connect to each other, the speaker, the band, and to God in a whole new and deeper way. That became our focus in planning NAMED 2015.

We started with our team's purpose: "to deeply connect students to God and to one another by engaging the Gospel in our everyday lives." With that as our mission statement we began to prayerfully plan what would become NAMED 2015. We also looked at what would be the "win" for this next conference. Our list included:

- "Together" experience the larger family of MB churches and strengthen the unity of the denomination.
- · "Inspiring Teaching That Equips" Entering into God's story at home and in the world.
- "Students Hearing God's Call On Their Life" This conference becomes a spiritual marker for their lives.
- "Creating Space For a God Moment" Connecting to God in a whole new way.
- "Spiritual and Numerical Growth For The Denomination" Going beyond having a mountain top experience but increasing the spiritual depth and numerical growth for the student ministries in our churches and future conferences.

We discussed the location and after months of research we narrowed it down to four sites. We then brought those locations as well as other information to the youth workers across the country in an online survey. The results confirmed what the team was already thinking: Denver. Denver rose to the top of the list due to: its central location so travel costs will be the lowest, its close proximity to fun activities and many restaurants, and its huge spaces at the Colorado Convention Center for meetings and sessions.

Location: NAMED 2015 will be held April 9-12, 2015 at the Hyatt Regency Downtown and the sessions will be held across the street at the Colorado Convention Center in Denver, CO. The difference from previous conferences is that this one will be Thursday night through Sunday morning.

Theme: Our theme is NAMED which comes from Matthew 16:13-16. In this passage Jesus asks Simon (Peter) "Who do you say I am?" He then answers, "You're the Messiah, the Son of the living God." With that answer Simon is given a new name, Peter, a name that captures the essence of his new identity and mission. Teenagers face labeling, low self-esteem, name calling and more consistently while in search for their identity. Our youth need to know that their true identity is found in Christ and not in the world. And when they know who Jesus is and who they are, they will discover where they are to go in this world.

Speaker: The speaker will be John Richardson, the campus pastor for Mountain View Community Church Sunnyside, Fresno, CA, a campus of Mountain View Community Church and a USMB church plant. He holds a bachelor's degree in Contemporary Christian Ministry from Fresno Pacific University, and a master's degree in Old Testament from Fresno Pacific Biblical Seminary. He was chosen because of his 10+ years of youth ministry experience, his passion for youth and missions, and his ability to connect with the audience.

Worship Band: The worship band will be For All Seasons. The five-member band has been a featured band at Hume Lake Christian Camp in CA. Their newest album High Above It All, is available on iTunes and on their

website www.forallseasonsmusic.com. They were chosen for their ability to connect with the audience and their experience in regularly leading large groups of teenagers into worship.

Learning & Service Ops: Once again we are having one day of Learning Ops (seminars) of various topics and from various speakers from around the world and a day of Service Ops (service projects) again working with D.O.O.R. that will set up inner-city service projects.

Cost & Registration (the biggest change): Cost will be \$299 per person, includes everything but meals and travel costs. Registration will be online this year at www.named2015.com. It opens January 1st and the final and ONLY deadline is March 1st, 2015. There is no early bird price, no deposit required. We are simplifying the entire registration process. ONE DEADLINE. ONE PAYMENT. ONE PRICE.

There will be a three step process for online registration:

- Each church's Lead Youth Worker will set up a username and password. (more information online)
- Parents then register their child under that church/group and submit their payment to their church's Lead Youth Worker.
- The Lead Youth Worker will then <u>double check</u> and submit all completed registrations with one payment for the whole church/group. Roommate arrangements will also be done online by the Lead Youth Worker.

There will be two payment options for churches:

Option 1: Pay online using a personal/church's credit/debit card or an electronic check

Option 2: Your church writes a check & postmarks it by March 1st

And Kyle Goings has gone from working as a Youth Pastor in the Central District to now working in the Southern District.

A Youth Worker's Summit happened in March 2014. It was a preview weekend where we invited all youth workers to spend the weekend in the same location the conference will be held. It was a time for connecting with other youth workers, receiving some encouragement and training, as well as learning all about what will be the youth ministry experience while at NAMED2015.

The team has met several times in person and talk regularly over the phone. The team is excited for what God has in store for the conference and beyond. Please continue to pray for NAMED2015.




- In January, The J.E. & L.E. Mabee Foundation issued a challenge grant for \$1 million towards the Center for the Arts, if we raise \$8 million by January 14, 2015.
- · Campus enhancements include: new parking lots, new cul-de-sacs, sidewalks and a remodeled and expanded cafeteria.

- The Council for the Accreditation of Educator Preparation (CAEP) did a thorough program review and granted continuous accreditation to the Education Department.
- The National Association of Schools of Music (NASM) did a thorough program review and granted continuous accreditation to the Music Department.
- Dr. Rick Bartlett, director of theological education at Tabor College in Wichita, developed a creative master of arts in entrepreneurial ministry leadership degree, which will launch in the fall of 2014.
- Dr. Brett Andrews was appointed as the new vice president of Tabor College in Wichita






Two years ago in Omaha, D. Merrill Ewert, Ph.D., passed the baton to me as President of Fresno Pacific University. In that time we have built on the past to do God's work in new and exciting ways, and I am happy to share a few of our successes with you:

- Strong enrollment—FPU has maintained about 3,500 students in our traditional undergraduate, graduate and degree completion programs. This stability allows us to prepare for a new phase of expansion as the Board of Overseers in June approved our plan to reach 5,000 students in the next several years.
- Growing regional centers—Our centers in Merced, North Fresno, Visalia and Bakersfield continue
 to serve adults completing their bachelor's degree or earning their master's. New initiatives include
 the expansion of the Merced Center by more than half its size, and the expansion of the Manna
 Moments devotional video program to all centers for use by faculty, staff and students.
- New degree programs—We've been strategic in introducing degrees that build on our strengths
 while addressing the needs of students and Valley communities. Recent examples include the
 Master of Science in Nursing degree, the B.A. in Health Care Administration and the B.A.s in
 Social Work and Social Welfare for degree completion students.
- Athletic success—Sunbird student-athletes continue to be a source of pride on and off the field.
 In winning it first NCCAA baseball championship, our team also brought home the sportsmanship
 award, the first time any team has claimed both prizes. All teams combined to win the Pacific West
 Conference's Community Engagement Award for service, and FPU is nearing the completion of its
 entrance into the NCAA Division II.
- Leaders in place—Speaking of teams, we now have permanent appointments in all senior
 executive positions: Stephen Varvis, Ph.D., as provost; Wesley Qualls as vice president for finance
 and business affairs; Alan Ours as vice president for operations; Jon Endicott as vice president for
 enrollment management; Diana Bates Mock as vice president for advancement and university
 relations; Terry Brensinger, Ph.D., as vice president and dean of Fresno Pacific Biblical Seminary;
 Brice Yocum as executive director for regional centers; Mark Isaac as associate vice president of
 advancement; Leslie Schuemann as director of athletics; and Karin Chao-Bushoven as director of
 major gifts.
- Commencement story—We took commencement off campus this May and scored big at Grizzlies Stadium (the AAA affiliate of the San Francisco Giants) in downtown Fresno. Speaker Randy White, D.Min., associate professor of community transformation, did a marvelous job of expressing FPU's commitment to its community by infusing humor and conviction into his challenge to the graduates.
- Outside honors—What we do we do for God, but when others notice it's another chance to witness
 to the Lord's glory. In 2013 FPU took a 30-place jump in the U.S. News & World Report list of best
 colleges and universities, and The Chronicle of Higher Education placed us in its top 10 nationally
 among Hispanic-Serving Institutions at graduating Hispanic students.

Fresno Pacific University's mission calls for us to develop students for leadership and service through excellence in Christian higher education. Through our work and with your support, God is indeed transforming lives. Your partnership and prayers for ongoing success are deeply appreciated.



God is doing something new at the seminary! As the new dean this year, I selected Isaiah 43: 18-19 as our theme verses. "Do not remember the former things,... I am about to do a new thing; now it springs forth, do you not perceive it?" FPBS has a rich and exciting past; a past that many people rightly celebrate. - New Colleagues: We welcomed two new faculty members and a director of admissions this past year. We look forward to welcoming Brian Ross who will teach in our Master of Divinity and MA Christian Ministries programs this fall semester.

 is now larger than it has been in many years. Included in this increase in enrollment are students
 in all of our programs, and several new students have come to FPBS to study Urban Mission.
 Nathan Hunt, for example, has come from Texas to study Urban Mission and participate in the work
 of our Center for Community Transformation. He, among many others, continues to bring fresh
 ideas and youthful enthusiasm to our campus.
- New Vision: The needs and challenges of our modern world invite us—require us!—to think
 outside of the box at times. Fortunately, these same challenges present us with new opportunities
 to expand our sphere of influence. As a result, we are currently designing new strategies and
 designs that will enable us to influence more people, both in Fresno and beyond.

God is faithful and is able to do abundantly more than we could ever ask or think. Our seminary is blessed with an outstanding and committed faculty, engaging students, and a wonderful context in which to carry out our work. We also have no shortage of ideas and a deep passion to serve the Lord in today's world. We believe, however, that even our greatest efforts fall flat without the empowering presence of the Holy Spirit. Fuel for Ministry

Since Don Faul was a young boy growing up in Velva, N. Dakota, he felt the call of God to be a foreign missionary. During his teens, he read a book about a missionary in Brazil that stirred his heart toward that country. He graduated from Bible school in Canada, earned a BA from Tabor College in Hillsboro, KS, a BD from MB Biblical Seminary in Fresno CA, and finally a MTh from Dallas Theological Seminary. While at seminary, President J. B. Toews informed him that he needed a wife.

Marie Klippenstein, a Canadian, felt God's call to foreign missions shortly after being baptized at age 15. After completing nurse's training in Winnipeg, Canada, she became aware of Kings View Hospital in Reedley, CA and moved there to start her nursing career.

Through mutual friends, Don and Marie met, dated for 8 months, and married in December, 1960. In 1962 they joined Mennonite Brethren Missions and Services and soon arrived in Curitiba, Brazil. Upon returning to Fresno in 1969, they helped start North Fresno MB Church, and later, they helped start Fig Garden MB Church in northwest Fresno.

In 1981, they agreed to return to Brazil and stayed for 14 years. Working alongside a national pastor, they were able to plant a MB church in Mundo Novo which has over 100 members today. Don wrote a Bible study book that was instrumental in discipling the local pastors and is still in use in Brazil and India today.

During their time in Brazil, the Faul's were able to purchase 7 acres of pistachio trees in Madera County. Over time, their ownership grew to 30 acres. Through the years, the trees have had good yields, and the price of the nuts has increased! This has been a great blessing to Don and Marie. They have been amazed at the profitability of this venture and give all the credit to God. Don said, "God gave us this money from our trees, and it is up to us to give it back to Him."

The Fauls have had great joy from their work with the churches in Brazil. With the bounty God has given them, they were able to send one of the church leaders through a Haggai Institute for a month of training in Singapore. She has led many to Christ and is beginning to train others. They have also paid tuition for several of the national pastors to study at a local seminary.

With the Planned Giving Services of MB Foundation, the Fauls have been able to make gifts, both now and in the future, to the ministries they love. They recently gifted 10 acres of pistachio trees and set up an Endowment to benefit MB Mission. They have created several Charitable Gift Annuities for the benefit of various ministries. When the Fauls pass away, their Revocable Living Trust will fund a gift to ministry.

God has been at the center of lives lived rich in ministry and service. Over the years He has provided for Don and Marie. Through their charitable giving plans with MB Foundation, they are honoring God and continuing to serve the ministries they love by providing fuel for ministry for years to come.







Fishing for People

Arthur Loewen is a local businessman in Abbotsford, BC who loves sharing the Gospel. . On a recent mission trip to the Philippines with our Disciple Making International program, Arthur shared the Gospel with a group of rural laborers next to a rice paddy. A number of people responded, including a medium and four other members of a local spiritist group.

Later that evening, Art climbed up into the hills to a remote village where forty others were waiting to hear the Gospel. After Art shared his testimony and presented the story of Jesus, he asked how many were expecting to go heaven. Most indicated that they weren't good enough, but they thought that trying harder to do good things might help. When they clearly understood that Jesus had made a way possible for us to experience peace with God, twenty-nine people prayed to receive Christ.

Jesus said, "Follow me, and I will make you fishers of men."

As they talked about what it meant to follow Jesus, the group of new Christ-followers asked whether they could start a new church in their community. The pastor who accompanied Art to the village committed to walking with this group and helping with their discipleship. A church was born that evening.

In reading through the book of Acts again recently, I was struck with how incredibly bold and verbal the first disciples were in sharing the reality of Christ's death and resurrection. There were a number of straightforward and even confrontational presentations of the Gospel, often at great personal cost.

One of the loudest preachers was Peter. We remember his first conversation with Jesus years earlier while he was fishing and Jesus said, "Follow me, and I will make you fishers of men" (Matthew 4:19).

Fishing for people is something we learn. It's not a gift that we're born with. Who are we learning this skill from in our lives? Who are we teaching to fish for people?

Despite the freedom of religion and freedom of speech in western societies, many Christ-followers live as though our tongues had been cut out. It seems that the fear of man has become more powerful than our love for Christ and for his Gospel. It's ironic that the best examples of bold proclamation are coming, not out of the West, but rather out of societies where there are heavy restrictions from totalitarian governments.

It takes courage to preach the Gospel. But when we pray for those opportunities to speak into peoples' lives, God gives them. When we love people and ask good questions, it's amazing how many good conversations develop.

We recently sent a team from Thailand into a neighboring country. The team was led by a gifted evangelist and church planter who invited a number of younger interns to join him. Despite the opposition of local authorities and a history of arresting Christian leaders in this nation, this team courageously went into a remote tribal area and openly proclaimed the Gospel. In a village without any known believers, the first person to respond to the Gospel was a woman who was 104 years old! When they held the baptism, this old woman insisted on getting into the tank (a converted water trough) without any assistance from others and then boldly shared her testimony with her fellow villagers.

This team's bold witness, fervent prayer and diligent follow-up are among the reasons for why the church is growing so quickly among this people group. As disciples who make disciples, we learn by watching, then doing, then teaching others.

I've learned much in ministry from my dear brother, Carlin Weinhauer, who went home to his reward on April 19, 2014. Carlin passed away the day before Resurrection Sunday and I thought of him that next morning as we sang about the hope we have because Jesus is alive. I don't think there's any place that Carlin would have rather celebrated that morning than in the presence of the Lord!

It takes courage to preach the Gospel.

Carlin would often say to me, "Prayer is the work." He also liked to remind me that, "Leaders need fresh bread every morning." Another of his wise sayings was, "Let's keep big things big and little things little." For Carlin, the Gospel was a big thing. He reminded us of the importance of living and sharing the Gospel every day. He never tired of sharing how the Gospel had transformed his life!

For a number of years, Carlin and I toured our constituency together sharing stories of transformation at "Celebrate Mission" nights and services all over North America. Carlin understood that the least reached mattered to God.

At Carlin's request, we have made it possible to honor his passion for mission by receiving donations to Global Church Planting through the Carlin Weinhauer Memorial. These funds will go toward sending teams to the most-challenging, least-reached places on this planet. It's a fitting legacy for a leader who loved the Gospel, was transformed by it, and called others to proclaim it in word and deed.

We'd like to encourage you with how God is using proclamation to reach the ends of the earth. Please read the Summer edition of Witness to hear testimonies of transformation from all over the world. Let's keep sharing the Good News!






Total Expenditures: \$11,065,591


Report to U.S. Conference of Mennonite Brethren Churches, Conection 2014



MCC at work

- Through partners in Syria, Jordan and Lebanon, MCC is meeting needs arising from the war in Syria. The response includes food assistance, kits, clothing, blankets, heaters, peacebuilding and more.
- Responding to the Nov. 2013 Typhoon Haiyan in the Philippines, MCC through partners provides food assistance, disaster-resistant shelters, agricultural support, training in trauma healing and future disaster response and more.
- More than four years after the 2010 earthquake in Haiti, MCC continues to address long-term needs such as housing, vocational training programs and advocacy for Haitians' human rights.
- MCC responded to violence in South Sudan that surfaced in late 2013 and continued into 2014 with food for people who remained, plans to provide food for refugees in neighboring Kenya, financial assistance for leaders from the South Sudan Council of Churches attending peace talks, and efforts to assist with recovery from trauma and the documentation of human rights issues.

2014 REPORT TO US MENNONITE BRETHREN

MHS continues to carry out our mission to strengthen and extend Anabaptist-affiliated health and human services organizations, including Mennonite and Brethren in Christ. We are a network of 73 organizations located in 17 states and Puerto Rico. Four members – Fairview Fellowship Home and Village, Lincoln Glen Manor, Palm Village and Parkside Homes – are Mennonite Brethren affiliated.

HIGHLIGHTS

In January 2013, we expanded our team to provide a broader range of consulting services to non-profit organizations and opened a new office in Camp Hill, Pennsylvania. As part of the expansion, we studied our brand and made a decision to use the name "MHS" rather than Mennonite Health Services in order to better represent who we are and who we serve.

In early 2014, we accepted the resignation of Sheri Plett Wiedenhoefer from our board, with appreciation for her two years of service. As a member of the Governance Committee, Sheri helped develop a policy on conflict resolution. The USMB Leadership Board has appointed Valerie Rempel to represent the denomination and we are pleased to welcome her back. She previously served on our board from 2003 – 2012.

- Another priority is to prepare executives to lead in ways that reflect the mission and values
 of their organizations. We are creating a repository of resources for leaders to equip them to
 nurture organizational practices that are shaped by Anabaptist values and beliefs.

MHS strives to be a community where staff and board leaders of member organizations can support each other as well as access other resources. Our membership programs include an Executive Circle to support CEOs, tools for board and CEO assessment, guides for executive transition and insurance programs for liability and health. MEMORANDUM OF UNDERSTANDING REGARDING MENNONITE BRETHREN HISTORICAL COMMISSION

2007 2014 proposed update

This Memorandum is entered into between the United States Conference of the Mennonite Brethren Churches ("the U.S. Conference") and the Canadian Conference of Mennonite Brethren Churches ("the Canadian Conference") in order to formalize their agreement regarding the ongoing operation of the Mennonite Brethren Historical Commission.

INTRODUCTION

Since 1969, the Historical Commission of the General Conference of Mennonite Brethren Churches has been charged with the collection and preservation of historical materials relating to the Mennonite Brethren churches of the United States and Canada. It has served as a clearinghouse and coordinating agency between the various Mennonite Brethren regional archival centers and has also overseen the Fresno center and its work of collecting General Conference archival materials. The national conferences recognize the value of these responsibilities and desire to continue the work of the Commission following divestiture of the General Conference ministries to the national conferences.

The national conferences acknowledge and affirm that the Mennonite Brethren of North America have a rich history which that must not be forgotten. The work of the Historical Commission has been critical to securing that heritage for future generations. In addition, the Commission has been instrumental in preserving the history of the greater Mennonite Brethren community, from local congregations to Mennonite Brethren conferences around the world. The national conferences feel strongly that the discontinuance of a bi-national North American conference must not jeopardize the preservation of the denomination's historical foundations.

The national conferences therefore agree to covenant together to continue the mandate and ministry of the Historical Commission through a bi-national partnership.

LEGAL STATUS

The present work of the General Conference Historical commission will be continued by a bi-national commission which will be known as the Mennonite Brethren Historical Commission. The Commission will not have a separate legal existence. Instead, it will operate under the oversight of the US Conference and the Canadian Conference, with its financial affairs managed by Fresno Pacific University ("FPU") and the Canadian Conference. Accounting and bookkeeping services will be provided by FPU. but will operate under the legal charter of the Mennonite Brethren Biblical Seminary (MBBS) in both the United States and Canada.

The Commission will report to the regularly scheduled conventions of the US and Canadian Conferences. In addition, it will communicate as needed with the executive personnel and executive bodies of the US and Canadian Conferences.

MEMBERSHIP AND STRUCTURE

The Commission will be composed of six members and should include, but not necessarily be limited to, individuals with competence in historical research and archival work. Members shall be selected as follows:

- 23 elected or appointed by the Canadian Conference;
- 23 elected or appointed by the United States Conference;
- 1 appointed by each of the national conferences.

All commission members must be members in good standing of a church congregation which that is a member of one of the national conferences.

Commission members will serve four-year terms. Any limit on the number of consecutive terms served by a member will be determined by the respective national conferences. Terms will be staggered in order to allow for continuity and balance of membership.

The Commission will organize itself by selecting a Chair, Associate Chair and Recording Secretary from among its elected and appointed members, to serve for terms to be determined by the Commission. The Chair and Associate Chair will come from different national conferences and the nationality of the persons filling these roles will normally alternate between the two conferences.

An Executive Secretary will be selected by the Historical Commission and be employed by a legal entity (e.g., a Mennonite Brethren school, Conference or congregation). The Historical Commission will reimburse the legal entity for the employee's salary and benefits, according to the funding arrangement made between the Historical Commission and the legal entity.

In addition, one representative from each of the regional archival centers (currently located in Hillsboro, Fresno, Winnipeg and Abbotsford) shall sit on the Commission as ex officio members.

Representatives of historical committees from other Mennonite Brethren national conferences may be invited to participate with the Commission as liaison members. In the future, consideration may be given to formally adding additional member conferences to the Commission and/or evolving the Commission into an ICOMB-based agency.

FUNDING

Each national conference shall provide the Commission with an annual grant (currently of \$17,000 (US). Periodic review of this amount will take place with the leadership boards of the national conferences. The accounting of this budget shall be done through the offices of MBBS, but shall be separate and apart from funding provided by the national conferences for the operation of MBBS. The Commission's budget and financial statement will be provided annually to the leadership boards of the US and Canadian Conferences.

Additional funding for the work of the Commission will continue to be provided by the Cloud of Witnesses endowment Endowment, which is held by Mennonite Brethren Biblical Seminary Foundation; and by the Historical Commission Endowment, which is held by the Canadian Conference of Mennonite Brethren Churches.—for the work of the Historical Commission.

REVIEW

The agreements set forth in this memorandum of understanding and the relationships established herein will be reviewed jointly by the national conferences at least every five four years to determine whether any changes are desired.



BYLAWS OF

MENNONITE BRETHREN

MISSION AND SERVICE INTERNATIONAL MB MISSION (Ratified July 2006 Proposed summer 2014 at USMB and Canadian MB Conventions)

PREAMBLE

These Bylaws constitute the rules for managing the operation of the global mission program of the United States Conference of the Mennonite Brethren Churches ("the U.S. Conference") and the Canadian Conference of Mennonite Brethren Churches ("the Canadian Conference").

ARTICLE I. GENERAL

SECTION 1. Name. The corporation shall be referred to as Mennonite Brethren Mission and Service International MB Mission (hereinafter "the Corporation").

SECTION 2. <u>Purpose</u>. The purpose of the Corporation shall be to operate global Christian mission programs by training and sending missionaries to all parts of the world, as well as financing mission programs in cooperation with international partners. The Corporation shall carry out its purpose in accordance with the Great Commission proclaimed by Jesus Christ in Matthew 28:19-20a: "Therefore go and make disciples of all the nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you." (NIV).

SECTION 3. <u>Confession of Faith</u>. The Confession of Faith of the U.S. and Canadian Conferences of the Mennonite Brethren Churches (hereinafter "the Confession of Faith") shall also be the confession of faith of the Corporation. <u>Any doctrinal statement issued by the Corporation shall be in complete harmony with the Confession of FaithDirectors and key staff will be asked to affirm the Confession of Faith from their country of residence.</u>

SECTION 4. <u>Policies and Procedures</u>. The Corporation may, from time to time, establish policies and procedures setting forth, in more detail, guidelines concerning the Corporation's operations and structures. Commissions or committees described herein may also be authorized to establish such policies and procedures. Any such policies and procedures shall be subject to and in harmony with the Confession of Faith, these Bylaws and the Articles of Incorporation of the Corporation.

SECTION 5. <u>Fiscal Year</u>. The fiscal year of the Corporation shall begin on the first day of June in each year.

ARTICLE II. CORPORATION STRUCTURE AND PROCESS

SECTION 1. Membership. The members of the Corporation shall consist of the U.S. Conference and the Canadian Conference (hereinafter collectively referred to as "the National Conferences"). These conferences shall each be represented by their elected governing boards. from time to time, appoint a person who shall be their authorized representative. Such representative shall be entitled to receive notice of, attend and vote at all meetings of the Members of the Corporation.

SECTION 2. Meetings.

- A. National Conference Conventions. The periodic conventions of each of Conferences, Thay serve as indedings of the portion of the Cofpoidation:

 there represented when expressly provided in these bylaws, and may serve as meetings of the portion of the Corporation there represented at the direction of the Board of Directors of the Corporation, for the purpose of:
 - (i) Affirming National Convention appointed members directors of the Board of Directors of the Corporation as set forth in these Bylaws;
 - (ii) Receiving reports from the Board of Directors and officers and employees of the Corporation;
 - (iii) Bringing concerns and suggestions from the National Conferences to the Board of Directors and administration of the Corporation;
 - (iv) Transacting such other business as may be submitted by the Boards of Directors of the National Conferences or the Corporation's Board of Directors, if otherwise authorized by law.
- B. <u>Annual Meeting</u>. The Board of Directors shall call the annual meeting for a date within the first six months of the beginning of the fiscal year of the Corporation, and the fixing of the date of the meeting by the Board shall constitute adequate notice to members of the date of the annual meeting. The Board of Directors shall serve as the representatives of the members of the Corporation for the purpose of conducting the annual meeting.
- C. Officers. The officers of the Corporation's Board of Directors, as elected by the Board, shall also serve as the officers of the Corporation. The Chair of the Board of Directors, or in the Chair's absence the Vice-Chair, shall preside at all meetings of the Corporation, except that, at any National Conference Convention, the presiding officer of said convention may also serve as presiding officer for the purpose of conducting business relating to the Corporation as set forth in Article II, Section 2.A. of these Bylaws.
- D. <u>Transaction of Business</u>. A majority of voting representatives present at any meeting shall determine any matters submitted, except when a larger percentage is required by law or these Bylaws.
- E. <u>Governance.</u> The Corporation shall be governed in accordance with Article III of these Bylaws which are expressly approved by the National Conferences.

ARTICLE III. GOVERNANCE STRUCTURE AND PROCESS

SECTION 1 Board of Directors

A. <u>Representation</u>. The Board of Directors (herein after the Board) shall consist of not less than eight (8), nor more than twelve (12) <u>members directors</u>. A majority of the <u>members directors</u> of the Board shall

be appointed elected from the National Conferences. The Board shall be constituted as follows:

- (i) Four (4) members directors shall be appointed elected by the Board of Directors of the U.S. Conference and affirmed at their conference convention:
- (ii) Four (4) members directors shall be appointed elected by the Executive Board of the Canadian_-Conference and affirmed at their conference convention;
- (iii) Up to four (4) membersdirectors, having full voice and voting rights, shall be appointed elected by the Members from among the nominees nominated by the Corporation's Board of Directors at its sole discretion;
- (iv) Members of the Board shall not be allowed to attend meetings of the Board through proxies.
- B. Qualifications. Members Directors of the Board who are appointed by the National Conferences shall be members in good standing of a church congregation which is a member of the respective National Conference. The National Conferences may consult with the Board in identifying nominees for Board membershipdirectors to ensure that desired expertise, giftedness and diversity are represented on the Board.
- C. Term of Office.
 - (i) The length of term of a U.S Conference or Canadian Conference appointed member of the Boarddirector shall be four years, and the number of consecutive terms that may be served by such a member, shall be governed by the bylaws of the National Conference from which the member is appointed; except that in the absence of any such governing bylaw then a one year term shall apply. The terms of such members shall commencinge upon the member's director being elected appointment; (ii) The term of a member of the Board appointed by the Board shall be four (4) years, unless a lesser term is designated by the Board, and shall commence immediately upon appointment unless otherwise designated by the Board.
- D. <u>Staggered Terms</u>. To the greatest extent possible, the terms of Board members shall be staggered to allow for continuity and balance of membership. The Board shall consult with the National Conferences regarding any adjustments to terms necessary to accomplish these objectives.
- E. <u>Vacancies</u>. If any vacancy shall occur in the membership of the Board by death, resignation, removal or otherwise, the unexpired term of said vacated position shall be filled as follows:
 - (i) A vacated conference appointment may be filled by appointment by the respective National Conference board. the remaining Directors of that respective National Conference.
 - (ii) A vacated board appointment- may be filled by appointment by the Board.
- F. <u>Authority</u>. The ultimate sources of authority for the Board are the National Conferences, in their capacity as members of the Corporation.
 - (i) Sources. The Board shall have all of the powers of a corporation under state law including the powers, directly or by delegation, to manage the property, services, affairs

and business of the Corporation, and shall have the power, directly or by delegation, to carry out any other functions which are permitted by the Articles of Incorporation or by these Bylaws, except insofar as such powers may be limited by law or reserved to the entire membership of the Corporation.

- (ii) Limits. In exercising its authority, the Board may not cause or allow the Corporation to be in violation of the laws in the countries where it is registered or operates, or of these Bylaws.
- G. Removal. A conference appointed member elected director may be removed by action of the National Conference which appointed elected the member director. A Board appointed member nominated director may be removed by majority vote of the Board Members.
- H. **Board Responsibilities** The functions of the Board include the following:
 - (i) Design the Board's structure and governance processes
 - (ii) Provide strategic leadership by determining the Corporation's values, beneficiaries and services, vision, mission and priorities
 - (iii) Delegate management authority and responsibility to the Executive Director
 - (iv) Monitor risk management and performance and measure strategic results.
- I. <u>Expectations of Responsibilities.</u> In fulfilling its responsibilities the Board is expected to:
 - (i) Seek and respect the counsel of the constituent churches of the National Conferences in its strategic planning process and in its governance of the vision, mission and priorities;
 - (ii) Maintain strong constituency relations with the churches that make up the National Conferences;
 - (iii) Appoint and evaluate the Executive Director of the Corporation;
 - (iv) Promote research and make environmental scanning field visits;
 - (v) Carry out a program of orientation for Board members directors;
 - (vi) Monitor financial condition and the quality of relationships;
 - (vii) Measure the impact of the ministry of the Corporation.

J. Monitoring Performance and Measuring Results

- (i) The Board is accountable to the membership of the Corporation of the National Conferences, through their elected governing boards and to any other representatives who may be designated by these bylaws and to the appropriate legal and regulatory authorities.
- (ii) The Board's accountability shall include the submission of required documentation to applicable authorities and clear and true reporting to the National Conferences.

SECTION 2. Officers

- A. <u>Positions</u>. The Board shall elect the following officers in order to properly conduct Corporation affairs:
 - (i) Chair. The Chair shall preside at all meetings of the Corporation (unless otherwise provided for herein) and the Board. The Chair shall be a non-voting ex officio member of all Board committees and commissions and shall perform such other duties as are incident to this office.

- (ii) Vice-Chair. The vice-chair shall serve as assistant to the Chair and take the place of the Chair during the Chair's absence or inability to serve.
- (iii) Secretary. The Secretary shall be responsible for the minutes of the Board. The Secretary may or may not actually serve as recording secretary. In the event the Board designates another individual as recording secretary, the Secretary shall be responsible for reviewing and approving the minutes to ensure the accuracy thereof. The Secretary shall perform all such other duties as are incident to this office.
- (iv) Treasurer. Chief Financial Officer. The chief financial officer, who may also be called "treasurer," shall provide expertise and oversight regarding the Corporation's financial operations; and shall The board treasurer shall perform such other duties as may be designated by the Board.
- (v) Other. The Board may elect such officers as, from time to time, it deems necessary in order to properly conduct Corporations affairs.
- B. Eligibility. Any duly elected or appointed member of the Board director shall be eligible to serve as an officer in the role of board Chair, board Vice-Chair, Secretary, or Treasurer. Any individual who is a member in good standing of a church congregation which is a member of one of the National Conferences shall be eligible to serve as an officer under Section 2 A (v):
- C. <u>Term</u>. All officers of the Corporation shall hold office for a term of two (2) years, unless an officer's term as director shall end before the end of that term, in which case the officer's term shall automatically end when his or her term as director ends; or unless the Board removes the officer, which removal may be at the discretion of the Board.
- D. <u>Vacancies</u>. Vacancies in any office created by resignation, death, removal, or otherwise, shall be filled by the Board for the remainder of the term of the officer whose office has been vacated.

SECTION 3. GOVERNANCE PROCESS

- A. Regular Meetings. The Board shall meet regularly at least two times during the year. Meetings shall be conducted in accordance with generally accepted rules of order. The Board shall determine such meeting dates and no particular form, mode or timing of notice is required.
- B. Special Meetings. Special meetings of the Board may be called by the Chair or by a majority of the members of the Boarddirectors for such place as may be specified. Notice of special meetings shall be given at least ten (10) days prior to the time fixed for such a meeting. By consent of the Board, special meetings may be held without notice.
- C. **Quorum.** A quorum for the transaction of business at any regular or special meeting of the Board shall consist of a majority of the total number of **Board members** directors then appointed to the Board.
- D. <u>Votes.</u> Decisions of the Board shall be determined by a majority of all votes cast unless otherwise required by these Bylaws. Any action required or permitted to be taken at any meeting of the Board or any committee or commission thereof may be taken without a meeting and by mail ballot, fax ballot or e-mail ballot at the discretion of the Chair of the Board or the

chair of the committee or commission.

E. <u>Closed Sessions.</u> The Board shall retain at all times the power to invite and permit administrative personnel and/or other persons to observe or participate in Board meetings; however, nothing in this subsection or in these Bylaws shall be construed to give ex officio status or other rights of participation or voting rights to such persons who are not members of the Boarddirectors. To the extent to which administrative personnel are by normal or special invitation present at or included in Board meetings, the Board nonetheless may, at the discretion and call of the Chair, meet in closed session without prior notice.

F. Proxies. Directors shall not be allowed to attend meetings of the Board through proxies.

ARTICLE IV. AMENDMENTS AND REVISIONS TO BYLAWS AND ARTICLES OF INCORPORATION

SECTION 1. Procedure. An amendment or revision to the Bylaws or Articles of Incorporation of the Corporation may be proposed by the Board of Directors or by either of the National Conference members of the Corporation. If an amendment or revision is proposed, it shall first be submitted to the Board at least 90 days prior to the national or special convention(s) at which it will be acted upon, and the Board shall prepare the proposal for formal presentation to the convention(s).

SECTION 2. <u>Approval</u>. A proposed amendment or revision to the Bylaws or Articles of Incorporation of the Corporation may be acted upon by submitting the proposed revision or amendment to the National Conferences for consideration. A proposed revision or amendment shall be deemed to be adopted by the membership of the Corporation if approved by both of the National Conferences. Approval by a National Conference shall occur upon the affirmative vote of two-thirds (2/3) of the voting representatives at a regular or special National Conference Convention. In the event a proposed revision or amendment is not so approved by the National Conferences, it may be resubmitted to the National Conferences at a future time.

SECTION 3. Exception to Procedure. Notwithstanding any other provision contained herein, the Board of Directors shall be empowered to amend the Articles of Incorporation, if necessary, in order to change the name and/or address of the Corporation's agent for service of process.

SECTION 4. Content. No revisions or amendments to the Bylaws or Articles of Incorporation may in any way be in conflict with any part of The Confession of Faith.

ARTICLE V. DISSOLUTION

SECTION 1. <u>Procedure</u>. The Corporation may be dissolved only upon the affirmative vote of two-thirds (2/3) of the voting representatives present at each respective National <u>Conference Convention</u> at a special meeting for that purpose and called pursuant to Article II, Section 2.A. of these Bylaws.

SECTION 2. <u>Distribution of Assets.</u> Upon dissolution, the remaining assets of the Corporation shall be distributed in accordance with applicable law and in a manner recommended by the Board of Directors and approved by a majority vote of the representatives present and voting at the special meeting discussed in Section 1 of this Article.



1 INTERPRETATION

1.1 Meaning of Words

In this By-Law and all other By-Laws, resolutions and Board Regulations of the Corporation, unless otherwise defined:

- 1.1.1 "Act" means the Canada Not-for-profit Corporations Act, S.C. 2009, c.23, including the Government Regulations made pursuant to the Act, and any statute or regulations that may be substituted, as amended from time to time:
- 1.1.2 "Annual General Meeting" means an Annual General Meeting of Members;
- 1.1.3 "Appointed Director" means a Director appointed under section 6.1.3;
- 1.1.4 "Articles" means original or restated Articles of Incorporation, or Articles of Amendment, amalgamation, continuance, reorganization, arrangement, dissolution or revival:
- 1.1.5 "Board" means the Directors of the Corporation from time to time;
- 1.1.6 "Board Regulation" means a regulation passed by the Board in accordance with Article 8;
- 1.1.7 "Canadian Conference" means the Canadian Conference of Mennonite Brethren Churches;
- 1.1.8 "Canadian Director" means a Director elected under section 6.1.1;
- 1.1.9 "Confession of Faith" has the meaning in Article 2;
- 1.1.10 "Corporation" means *MB MISSION*;
- 1.1.11 "Director" means a member of the Board;
- 1.1.12 "Elected Director" means either a Canadian Director or a U.S. Director;
- 1.1.13 "Government Regulations" means the regulations made under the Act as amended, restated or in effect from time to time;
- 1.1.14 "Ineligible Individual" has the meaning in section 149.1 of the *Income Tax Act* (Canada), as amended from time to time;
- 1.1.15 "Member" means a person who has become a Member in accordance with section 3.1;
- 1.1.16 "Ordinary Resolution" means a resolution passed by Written Resolution or by a majority of the votes cast on that resolution;
- 1.1.17 "Officer" means an Officer elected or appointed pursuant to Article 9 or by Board Regulation.
- 1.1.18 "Public Accountant" means the Public Accountant of the Corporation appointed pursuant to Article 15;
- 1.1.19 "Special Meeting of Members" includes any meeting of Members that is not an Annual General Meeting;

- 1.1.20 "Special Resolution" means a resolution passed by Written Resolution or by a majority of not less than two-thirds (2/3rds) of the votes cast on the resolution; and
- 1.1.21 "U.S. Conference" means the United States Conference of Mennonite Brethren Churches;
- 1.1.22 "U.S. Director" means a Director elected under section 6.1.2;
- 1.1.23 "Written Resolution" means a resolution in writing signed by all the Directors or Members entitled to vote on that resolution at a meeting of the Board or the Members, as the case may be, and which is valid as if it had been passed at a meeting of the Board or Members.

2 CONFESSION OF FAITH

The Confession of Faith of the U.S. and Canadian Conferences of the Mennonite Brethren Churches (the "Confession of Faith") shall also be the confession of faith of the Corporation. Directors and key staff will be asked to affirm the Confession of Faith from their country of residence.

3 MEMBERSHIP

3.1 Composition

Subject to the Articles, there shall be the following two (2) classes of Members in the Corporation

- 3.1.1 the Canadian Conference; and
- 3.1.2 the U.S. Conference.

A Corporation or other entity may be a Member.

3.2 Members' Rights

Each Member shall be entitled to receive notice of, attend and vote at all meetings of the Members of the Corporation.

3.3 Appointment by Corporate Member

A Member that is a corporation or other entity shall, from time to time, appoint a person who shall be its authorized representative. Such Member shall provide the details and contact information of the authorized representative from time to time to the Executive Director or to the Secretary (or Secretary-Treasurer), either of whom shall immediately update the Corporation's records for the purposes of providing notice of all meetings to which the authorized representative is entitled to attend.

3.4 Termination of Membership

Membership in the Corporation automatically terminates upon the occurrence of any of the following events:

- 3.4.1 the resignation in writing of a Member of the Corporation;
- 3.4.2 the dissolution, insolvency or bankruptcy of a Member; or
- 3.4.3 the liquidation or dissolution of the Corporation under the Act.

3.5 No Compensation for Members

A Member shall not be entitled to any compensation upon termination of membership.

4 MEETINGS OF THE MEMBERS

4.1 <u>Annual General Meeting</u>

The Annual General Meeting of the Members shall be held within Canada, or, if all Members entitled to vote at the meeting consent, outside Canada, at a place and date and time determined by the Board, for the purpose of:

- 4.1.1 hearing and receiving the reports and statements required by the Act to be read and laid before the Corporation, which are:
 - 4.1.1.1 financial statements prepared in accordance with generally accepted accounting principles;
 - 4.1.1.2 the report of the Public Accountant, if any;
 - 4.1.1.3 any further information respecting the financial position of the Corporation and the results of its operations required by the Articles, By-Laws or unanimous member agreement.
- 4.1.2 appointing the Public Accountant and fixing or authorizing the Board to fix their remuneration; and
- 4.1.3 the transaction of any other business properly brought before the meeting.

The Annual General Meeting shall be held not later than fifteen (15) months following the last Annual General Meeting provided that any Annual General Meeting should be held within six (6) months of the financial year end of the Corporation.

4.2 <u>Meetings by Electronic Conference</u>

A Member may participate in a meeting of Members by means of an electronic or other communication device that permits all participants to communicate adequately with each other during the meeting. Any person participating by electronic conference is deemed to be present at that meeting. Any security, confidentiality or other considerations with respect to the conduct of such a meeting shall be as determined by the Board from time to time.

4.3 Special Meeting

The Board may at any time call a Special Meeting of Members for the transaction of any business specified in the notice calling the meeting. The Board shall call a Special Meeting of Members upon receipt of a written request for such a meeting signed by at least five percent (5%) of the Members entitled to vote.

4.4 Notice of Meetings

Notice of the time, place and date of any meeting of Members and sufficient information for a Member to make a reasoned judgment on the business to be considered shall be given to each Member entitled to vote at the meeting, to each Director and to the Public Accountant of the Corporation:

- 4.4.1 by mail, courier or personal delivery, during a period of twenty-one (21) to sixty (60) days before the day on which the meeting is to be held; or
- 4.4.2 by telephone, or other electronic means, during a period of twenty-one (21) to thirty-five (35) days before the day on which the meeting is to be held. If a Member requests that notice of a meeting be given by non-electronic means, the notice will be sent by mail, courier or personal delivery as provided in section 4.4.1.

4.5 Those Entitled To Be Present

The only persons entitled to be present at a meeting of Members shall be:

- 4.5.1 those entitled to vote at the meeting,
- 4.5.2 the Directors and the Public Accountant of the Corporation, and
- 4.5.3 such other persons who are entitled or required under any provision of the Act, the Articles or By-Laws of the Corporation to be present at the meeting.

Any other person may be admitted only on the invitation of the chair of the meeting or by Ordinary Resolution of the Members.

4.6 Quorum

- 4.6.1 A quorum for the transaction of business at meetings of the Members shall be at least a majority of all of the Members of the Corporation entitled to vote, and present in person or by telephone.
- 4.6.2 No business shall be transacted at any meeting of the Members unless the necessary quorum is present at the commencement of such meeting.
- 4.6.3 Provided however that where:
 - 4.6.3.1 less than a quorum, but two (2) or more, persons are present in person one-half hour after the commencement time specified in the notice calling the meeting of Members; and
 - 4.6.3.2 the business transacted is limited to the selection of a chair and a secretary for the meeting, the recording of the names of those present, and the passing of a motion to adjourn the meeting with or without specifying a date, time and place for the resumption of the meeting,

then two (2) persons present in person constitute a quorum.

4.6.4 If a quorum is not present at the opening of a meeting of Members, the Members present may adjourn the meeting to a fixed time and place but may not transact any other business.

4.7 Chair

In the absence of the Chair of the Board and the Vice-Chair of the Board, the Members present and entitled to vote and present at any meeting of Members shall choose another Director as chair. If no Director is present or if all the Directors present decline to act as chair, the Members present and entitled to vote shall choose a Member to be chair.

4.8 Voting by Members

The method of voting at any meeting of the Members shall be determined by the chair of the meeting prior to any vote being taken. Each Member shall have one (1) vote on each question raised at any meeting of the Members, and all questions shall be determined by a majority of the votes cast. In the case of an equality of votes, the vote shall be deemed to have been lost.

4.9 Electronic, Mail or Telephone Voting

The Directors may provide for Members to vote by mail, telephone or electronic means. Such alternative means of voting must:

- 4.9.1 allow for verification that the votes are made by the Members entitled to vote; and
- 4.9.2 not allow the Corporation to identify how each Member voted.

4.10 Proxies

No proxy voting is allowed.

4.11 Ballot

A Member can demand a ballot during the meeting either before or after any vote by show of hands. The result of a ballot shall be deemed to be a resolution on that matter for which the ballot was requested.

4.12 Adjournments

Any meeting of Members may be adjourned to any time. Any business that might have been transacted at the original meeting from which the adjournment took place may be transacted upon the resumption of the adjourned meeting. No notice is required for the resumption of any adjourned meeting where the resumption of the meeting occurs less than thirty-one (31) days from the date of the original meeting.

4.13 Written Resolutions

A Written Resolution signed by all the Members entitled to vote on that resolution at a meeting of Members, including an Annual General Meeting, is valid, provided that the following matters may not be dealt with by Written Resolution:

- 4.13.1 the resignation, removal or replacement of a Director, where a written statement has been submitted by the Director giving reasons for resigning or opposing his or her removal or replacement; and
- 4.13.2 the resignation, removal or replacement of a Public Accountant, where a written statement has been submitted by the Public Accountant giving reasons for resigning or opposing his or her removal or replacement.

5 BOARD OF DIRECTORS

5.1 Board

Immediately following confirmation of this By-Law by the Members, the number of Directors shall not exceed twelve (12). The Members thereafter delegate to the Directors the right to fix the number of Directors from time to time.

5.2 Qualifications

Each Director shall:

- 5.2.1 subscribe to and support the objects of the Corporation;
- 5.2.2 be an individual who is at least eighteen (18) years of age;
- 5.2.3 not have the status of a bankrupt;
- 5.2.4 not be a person who has been declared incapable by a court in Canada or in another country;
- 5.2.5 not be an Ineligible Individual who has made disclosure to the Board as required by section 5.3, unless that person has received approval of the Board to remain a Director within thirty (30) days after such disclosure is made;
- 5.2.6 be a member in good standing of an MB Church of the Canadian Conference or of the US Conference; and

5.2.7 meet such additional qualifications as may be set out in the Board Regulations from time to time.

If a person ceases to be qualified as provided in this section 5.2, the person thereupon ceases to be a Director and the vacancy so created may be filled in the manner prescribed by section 5.5.

5.3 Duty to Disclose

Every Director or Officer who is or becomes an Ineligible Individual shall disclose such fact to the Board immediately upon learning that he or she has become an Ineligible Individual. Upon such disclosure being made, the Board may approve of the Ineligible Individual remaining as a Director or Officer. If the Director is not approved, the Director will be deemed to be no longer qualified pursuant to section 5.2 and will immediately cease to be a Director. The resulting vacancy may be filled in the manner prescribed in section 5.5.

5.4 Removal of Directors

Directors may by Ordinary Resolution be removed from office at a Special Meeting called for that purpose before expiration of the Director's term of office:

- 5.4.1 in the case of a Canadian Director, by the Canadian Conference;
- 5.4.2 in the case of a U.S. Director, by the U.S. Conference;
- 5.4.3 in the case of an Appointed Director, by the Members.

and the class or classes of Member, as the case may be, that has voted to remove the Director may elect a person to replace the removed Director for the remainder of the term of office.

Where the class of Members or Directors that have voted to remove the Director do not fill the vacancy created by the removal of a Director, the vacancy may be filled in accordance with section 5.5.

5.5 <u>Vacancies</u>

Subject to section 5.4, vacancies on the Board, except a vacancy resulting from an increase in the number or the minimum or maximum number of Directors provided for in the Articles for that class or from a failure to elect the number or minimum number of Directors provided for in the Articles for the class, shall be dealt with in the following manner:

- 5.5.1 where a vacancy occurs among the Directors elected by a class of Members,
 - 5.5.1.1 the remaining Directors elected by that class may fill the vacancy for the remainder of the outgoing Director's unexpired term, or
 - 5.5.1.2 if there are no remaining Directors elected by the class, or if the Directors do not fill the vacancy, any Member of the class may call a meeting of the class to fill the vacancy.
- 5.5.2 where a vacancy occurs among the Appointed Directors,
 - 5.5.2.1 so long as a quorum of Directors remains in office, the remaining Directors may fill the vacancy for the remainder of the outgoing Appointed Director's unexpired term, or
 - 5.5.2.2 if there is no quorum of Directors in office, or if the Directors do not fill the vacancy, any Member may call a meeting of the Members to fill the vacancy.

5.6 Remuneration of Directors

The Directors of the Corporation shall serve without remuneration. Directors shall, however, be entitled to receive reimbursement for reasonable expenses incurred in carrying out their duties on behalf of the Corporation.

6 ELECTION OF THE BOARD

6.1 Election of Directors

Subject to the provisions of the Act and Articles, Directors shall be elected in the following manner:

- 6.1.1 four (4) Directors shall be elected by the Canadian Conference, and shall be referred to as the "Canadian Directors":
- 6.1.2 four (4) Directors shall be elected by the U.S. Conference, and shall be referred to as the "U.S. Directors";
- 6.1.3 up to four (4) Directors shall be elected by the Members from among the nominees nominated pursuant to section 6.5.2, and shall be referred to as the "Appointed Directors".

6.2 <u>Election in Rotation</u>

At the first election of Directors following the confirmation of these By-Laws by the Members, Directors shall be elected for the following terms of office:

- 6.2.1 two (2) Canadian Directors shall be elected for four (4) years;
- 6.2.2 two (2) Canadian Directors shall be elected for two (2) years;
- 6.2.3 two (2) U.S. Directors shall be elected for four (4) years;
- 6.2.4 two (2) U.S. Directors shall be elected for two (2) years;
- 6.2.5 as near as possible to one-half of the number of Appointed Directors shall be elected for four (4) years; and
- 6.2.6 as near as possible to one-half of the number of Appointed Directors shall be elected for two (2) years.

Thereafter, the term of office of a Director shall be four (4) years. A Director's term of office will expire at the Board meeting that occurs four years after the Board meeting at which the Director's term began. If no successor is elected to replace the Director's at the end of his or her term, the Director's term expires when a successor is elected.

6.3 Ceasing to be a Director

A person shall immediately cease to be a Director:

- 6.3.1 upon delivering his or her resignation in writing to the Secretary or to the address of the Corporation;
- 6.3.2 upon the expiry of the Director's term under section 6.2;
- 6.3.3 upon his or her death;
- 6.3.4 upon being removed under section 5.4.

6.4 Elections

A number of Directors equal to the number of Directors retiring plus any vacancies then outstanding shall be elected each year at a Special Meeting of the Members called for that

purpose. The election of the Directors will take effect as of the first Board meeting following the Special Meeting at which the Directors were elected.

6.5 Nominations

Candidates for the office of Director shall include:

- 6.5.1 in the case of Directors elected by a class of Members, the persons whose names are put in nomination by that class of Members before the close of nominations at the meeting of Members at which the election of Directors is held.
- 6.5.2 in the case of Appointed Directors, the candidates proposed by the Nominating Committee and approved by the Board by Ordinary Resolution not later than the start of the meeting at which the election of Directors is held.

6.6 Nominating Committee

The composition of the Nominating Committee shall be determined by Board Regulation.

6.7 Forms

The Board may prescribe the form of nomination paper and the form of a ballot.

7 MEETING OF DIRECTORS

7.1 Calling Meetings

Meetings of the Board may be called by the Chair of the Board, the Vice-Chair of the Board, the Secretary or any two (2) Directors and shall be held at the place specified in the notice. The Board shall meet at least twice each year.

7.2 Regular Meetings

There shall be at least two regular meetings of the Board each year. The Board may appoint one or more days in each year for regular meetings of the Board at a set place and time. A copy of any resolution of the Board fixing the place and time of such regular meetings of the Board shall be sent to each Director as soon as possible after being passed, but no other notice shall be required for any such regular meeting except as may be required pursuant to the Act.

7.3 Notice of Meetings

Subject to the provisions of section 7.2, notice of Board meetings shall be given to each Director:

- 7.3.1 by telephone, fax, email or other electronic method at least five (5) days before the meeting is to take place, excluding the date on which notice is given; or
- 7.3.2 by prepaid letter post at least ten (10) days before the meeting is to take place, excluding the date on which notice is given.

7.4 Meetings by Electronic Conference

If all the Directors consent generally, or in respect of a particular meeting, any person entitled to attend a meeting of Directors may participate in a meeting by means of an electronic or other communication device that permits all participants to communicate adequately with each other during the meeting. Any person participating by electronic conference is deemed to be present at that meeting. Any security, confidentiality or other considerations with respect to the conduct of such a meeting shall be as determined by the Board from time to time.

<u>Provided</u> that at the outset of each such meeting, and whenever votes are required, the chair of the meeting shall confirm that a quorum is present.

7.5 Quorum

A quorum for the transaction of business at meetings of the Board shall be at least a majority of the Directors.

7.6 Voting

The method of voting at any meeting of the Board shall be determined by the chair of the meeting prior to any vote being taken. Each Director shall have one (1) vote on each question raised at any meeting of the Board, and all questions shall be determined by a majority of the votes cast. In the case of an equality of votes, the vote shall be deemed to have been lost. For greater certainty, the Chair of the meeting shall vote.

7.7 Written Resolutions

A Written Resolution, signed by all the Directors entitled to vote on that resolution at a meeting of Directors, is valid.

7.8 Electronic Signatures

Any matter requiring a signature of a Director, including Written Resolution, may be signed using an electronic signature that meets the following requirements:

- 7.8.1 the signature resulting from the use by the person of the technology or process is unique to the person;
- 7.8.2 the technology or process is used by the person to incorporate, attach or associate the person's signature to the electronic document; and
- 7.8.3 the technology or process can be used to identify its user.

7.9 Consensus

Subject to section 7.10, the Board may make decisions by consensus. A consensus is reached when:

- (a) every Director expresses agreement with the decision being taken; or
- (b) some Directors agree with the decision while others prefer a different decision but all Directors express a willingness to support the decision of the majority or plurality.

Consensus is not achieved when one or more Directors do not agree to support the decision of the majority or plurality. In the event that consensus cannot be reached, the decision shall be referred to a vote in accordance with section 7.6.

7.10 Matters that may not be decided by Consensus

Any matter requiring approval by Special Resolution may not be decided by consensus.

7.11 Adjournments

Any meeting of Directors may be adjourned to any time. Any business that might have been transacted at the original meeting from which the adjournment took place may be transacted upon the resumption of the adjourned meeting. No notice is required for the resumption of any adjourned meeting if the time and place of the adjourned meeting is announced at the original meeting.

8 BOARD REGULATIONS

8.1 Board Regulations

The Board may make Board Regulations with regard to any matter not inconsistent with the Act and the By-Laws. These regulations are outlined in a document identified as the "Board Governance Manual".

9 OFFICERS

9.1 Officers

There may be a Chair of the Board and such other Officers that may be elected or appointed by Board Regulation from time to time. Subject to the Act, the Articles and the By-Laws, the terms and duties of such Officers shall be defined in the Board Regulations passed by the Board from time to time.

9.2 Executive Director May Attend All Meetings

The Executive Director, if any, shall have the right to receive notice of, to attend and to speak at but not to vote (unless otherwise also a Director) at all meetings of the Board, any committee of the Board, including the Executive Committee, and any meeting of the Members, except those meetings where the terms of employment, compensation or performance of the Executive Director are discussed.

10 COMMITTEES

10.1 Committees

Subject to the Act and the By-Laws, the Board may by Board Regulation appoint such committees as it deems appropriate from time to time and set the rules governing such committees.

10.2 Executive Committee

The Board may appoint from among the Directors of the Corporation an Executive Committee and delegate to the Executive Committee any of the powers of the Directors except those powers listed in section 10.3.

10.3 Limits on Authority of Committees

No committee, including the Executive Committee, has authority to:

- 10.3.1 submit to the Members any question or matter requiring approval of the Members;
- 10.3.2 fill a vacancy among the Directors or in the office of Public Accountant or appoint additional Directors;
- 10.3.3 issue debt obligations except as authorized by the Board;
- 10.3.4 approve any financial statements;
- 10.3.5 adopt, amend or repeal any By-Law; or
- 10.3.6 establish contributions to be made, or dues to be paid, by Members.

11 CONFLICT OF INTEREST

11.1 Conflict of Interest

In accordance with the Act and any Board Regulations, Directors and Officers shall disclose any interests, whether direct, indirect or imputed, in any matter as required by the Act, and shall refrain from voting on any resolution related to that matter. Further guidance consistent with the Act may be provided by the Board Regulations.

12 EXECUTION OF DOCUMENTS

12.1 Execution of Documents

The Board may by Board Regulation prescribe the person(s) authorized to execute classes of documents on behalf of the Corporation. All documents executed in accordance with the Board Regulations are binding on the Corporation without further action or formality.

13 BORROWING BY THE CORPORATION

13.1 General Borrowing Authority

Subject to the Board Regulations, the Directors may, without authorization from the Members:

- 13.1.1 borrow money on the credit of the Corporation;
- 13.1.2 issue, reissue, sell, pledge or hypothecate debt obligations of the Corporation;
- 13.1.3 give a guarantee on behalf of the Corporation to secure performance of an obligation of any person; and
- 13.1.4 mortgage, hypothecate, pledge or otherwise create a security interest in all or any property of the Corporation, owned or subsequently acquired, to secure any obligation of the Corporation.

Subject to the terms upon which the Members have authorized the exercise of the above powers, the Directors may delegate these powers to a Director, committee of Directors, or Officer.

14 FINANCIAL YEAR

14.1 Financial Year Determined

The financial year of the Corporation shall terminate on the last day of May in each year or on such other date as the Board may determine.

15 PUBLIC ACCOUNTANT

15.1 Board May Make Initial Appointment

The Board may, following incorporation, appoint a Public Accountant to hold office until the first Annual General Meeting. The Public Accountant must meet the requirements in the Act.

15.2 Annual Appointment

Subject to the Act and its Government Regulations, the Members of the Corporation at each Annual General Meeting shall appoint one or more Public Accountants. The Public Accountant will hold office until the close of the next Annual General Meeting and if an appointment is not made, the incumbent Public Accountant continues in office until a successor is appointed.

15.3 Removal of Public Accountant

The Members, by Ordinary Resolution at a Special Meeting of the Members, may remove any Public Accountant before the expiration of the term of office in accordance with the Act.

15.4 Vacancy in the Office of Public Accountant

The Board shall fill any vacancy in the office of Public Accountant, but while the vacancy continues any remaining Public Accountant may act.

15.5 Remuneration of Public Accountant

The remuneration of a Public Accountant appointed by the Members may be fixed by the Members by Ordinary Resolution, or shall be fixed by the Board if the Members do not do so.

16 FINANCIAL STATEMENTS

16.1 Making Financial Statements Available to Members

The Corporation may, instead of sending copies of the annual financial statements and related documents to the members, publish a notice to its members stating that the annual financial statements and related documents are available at the registered office of the Corporation and any member may, on request, obtain a copy free of charge at the registered office or by prepaid mail.

16.2 Filing of Financial Statements with Corporations Canada

As required by the Act, and subject to any amendments to the Act, the Corporation shall file copies of its annual financial statements to Corporations Canada not less than 21 days before the Annual General Meeting of Members. If the Annual General Meeting is conducted by Written Resolution, a copy of the annual financial statements shall be filed with Corporations Canada as soon as possible following the signing of the Written Resolution by the Members.

17 NOTICE

17.1 When notice deemed given

When notice is given under the By-Laws by the following means, that notice is deemed to have been given at the following time:

- 17.1.1 If given by telephone, notice is deemed given at the time of the telephone call;
- 17.1.2 If given in writing by prepaid letter post to the last address shown on the Corporation's records, notice is deemed given on the third day after mailing;
- 17.1.3 If given in writing by courier or personal delivery, notice is deemed given when delivered:
- 17.1.4 If given by email, notice is deemed given when sent; and
- 17.1.5 If provided by other electronic means, notice is deemed given when transmitted.

17.2 Declaration of Notice

At any meeting, the declaration of the Secretary or chair of the meeting that notice has been given pursuant to this By-Law shall be sufficient and conclusive evidence of the giving of such notice. No formal notice of a meeting is necessary if all those entitled to notice are present or if those absent have signified their consent to the meeting being held without notice and in their absence.

17.3 Computation of Time

In computing the date when notice must be given under any provision of the By-Laws requiring a specified number of days' notice of any meeting or other event:

- 17.3.1 where reference is made to "at least", then the number of days does not include the day notice is given or the day of the meeting or event;
- 17.3.2 in all other cases the number of days shall exclude the day of the meeting or other event and include the day notice is given, unless otherwise provided; and
- 17.3.3 where the time for giving the notice falls on a holiday, the notice may be given on the next day that is not a holiday.

17.4 Omissions and Errors

Any resolution passed or proceeding taken at a meeting of the Board, a committee of the Board or Members shall not be invalidated by:

- 17.4.1 an error in notice that does not affect its substance;
- 17.4.2 the accidental omission to give notice; or
- 17.4.3 the accidental non-receipt of notice by any Director, Member or Public Accountant.

Any Director, Member or Public Accountant may at any time waive notice of, and ratify and approve any proceeding taken at any meeting.

17.5 Waiver

Where a notice or document is required to be sent pursuant to the By-Laws or the Act, the person entitled to receive the notice or document may consent in writing to waive either the sending of the notice or document or the time within which the notice or document must be sent.

18 BY-LAWS AND EFFECTIVE DATE

18.1 Effective Date of this By-law

This By-Law shall only be effective upon the issuance of the Corporation's Certificate of Continuance under the Act by Industry Canada.

18.2 Amendments requiring Special Resolution

Amendments to the following sections of this By-Law shall only be effective upon approval of the Members by Special Resolution:

- 18.2.1 Section 1.1.9;
- 18.2.2 Section 3.1;
- 18.2.3 Section 3.2:
- 18.2.4 Section 4.4;
- 18.2.5 Section 4.10;
- 18.2.6 Section 5.1; and
- 18.2.7 any section that adds, changes, or removes a provision that is contained in the Corporation's Articles.

18.3 By-Laws and Effective Date

Subject to the Articles, the Board of Directors may make, amend or repeal any By-Law that regulates the activities or affairs of the Corporation. Subject to section 18.2, any such By-Law, amendment or repeal shall be effective from the date of the resolution of Directors until the next

meeting of Members where it may be confirmed, rejected or amended by Ordinary Resolution of the Members.

If the By-Law amendment or repeal is confirmed or confirmed as amended by the Members, it remains effective in the form in which it was confirmed. The By-Law amendment or repeal ceases to have effect if it is not submitted to the Members at the next meeting of Members or if it is rejected by the Members at the meeting.

19 REPEAL OF PRIOR BY-LAWS

19.1 Repeal

Subject to the provisions of section 19.2 hereof, all prior By-Laws, resolutions and other enactments of the Corporation inconsistent in either form or content with the provisions of this By-Law are repealed.

19.2 Prior Acts

The repeal of prior By-Laws, resolutions and other enactments shall not impair in any way the validity of any act or thing done pursuant to any such repealed By-Laws, resolution or other enactment.
